# Metropolitan Coal operations update – Stephen Love, Environment & Community Superintendent

A presentation was provided to the CCC with an update regarding:

- Business Update
- Mining Update
- Annual Review
- Eastern Tributary Remediation
- LW308-310 Extraction Plan

# Questions/Comments/Feedback from CCC members in relation to the Presentation:

- PT enquired on the current price of coal from Metropolitan. JH explained average price for premium product is at \$185 / tonne adding coking coal prices have dropped during 2022.
   In contrast thermal coal prices remain very high.
- LA noted Resources Regulator was onsite, JH explained that the visit was a planned compliance audit for onsite explosives storage. SL added that the RR remit is quite wide and covers both safety and environmental compliance aspects of mining operations.
- SL provided insight into recent planned product coal trucking campaign to Bluescope due to rail outage. Supply chain issues across the economy meant few trucks were available, and minimal trucking occurred
- KB asked about recent heavy rainfall and impacts on site, SL referred to historical graph showing significant rainfall has occurred during 2022 with the most recent rainfall event delivering just under 500mm at Metropolitan's Weather Station.

 KB enquired about the water levels in Turkey's Nest Dam with reference to spilling to Camp Creek. SL confirmed conditions remain challenging due to frequent heavy rain but de-silting continues and the water treatment plant continues to operate effectively.

# **General Business:**

- LA read out late correspondence from AH, on behalf of Helensburgh Landcare & local
  residents concerned with the flooding of Helensburg Creek where it flows under Parkes
  Street with report of debris blocking culvert, causing minor flooding and WCC declining to
  assist. Response: SL confirmed he has inspected the culvert and noted significant debris
  buildup on the upstream side. Metropolitan will clear the debris and monitor culvert
  performance during next rain event. KB added that lots of debris had flooded into creeks
  during recent rainfall events.
- AH confirmed pathway to mine memorial at the Old Mine Surgery has been completed and signed-off by council.
- KB raised the poor state of the old mine wagons in Charles Harper Park. KO confirmed that he was assisting the Lions Club in replacing these.
- SL asked for any input from CCC members regarding a potential site visit during the next CCC meeting and if there are any specific areas of interest members might have. SL will coordinate with LA ahead of the next meeting.

Next meeting: 3:00pm 22 November 2022 and will include site inspection.
