

## Dear Sir / Madam

Enclosed is a Water Access Licence Certificate. It has been generated from the information held in the Water Access Licence Register operated by the Land and Property Information (LPI) Division of the NSW Department of Lands. The certificate has been sent to you because you are the nominated contact person for the licence or, in the case of mortgages or company charges over the licence, the security interest holder.

This Water Access Licence Certificate is a valuable legal document similar to a Land Certificate of Title. It should be stored carefully with other legal documents. Should the certificate be lost or badly damaged, an application for a replacement certificate can be made to LPI.

To transfer, mortgage, subdivide or make other changes to the water access licence (known as dealings) this certificate must be presented at the LPI Office to register the dealing on the Water Access Licence Register. The next edition or a new Water Access Licence Certificate is then issued.

To find out the most up-to-date information on a water access licence, you can undertake an on-line search of the Water Access Licence Register at any time via the Department of Lands website.

A guide is enclosed which explains the information shown on the licence certificate or generated via a search of the Water Access Licence Register. It also shows where you can obtain additional information.
