Attended Noise Monitoring

- 9 – 10 December 2024 with two audible locations during the monitoring period
- 21 – 22 January 2025 with five audible locations during the monitoring period
- Noise monitoring compliant with conditions

*Question: Regarding the discussion at the December meeting, there should be more information incorporated into these presentations about the noise monitoring and that there was an agreement that the dBc levels would be reported. There does not seem to be dBc levels reported in this presentation*

*Answer: It should be included in the reports; if it isn't included then it can be rectified by WCPL*

Blasting

- November x8, December x7, 2024, and January x10, 2025, blasts were compliant with maximum vibration limits
- Blast overpressure monitoring was compliant for each month

Air Quality

- Depositional dust was compliant for the monitoring period
- Depositional Dust Gauge example is shown and talked to, to provide context about how they work relevant to the CCC

*Question: Is this type of dust gauge standard across the industry?*

*Answer: Yes, they are used frequently throughout the industry*

- HVAS (High Volume Air Sampler) location map shown
- HVAS results are compliant for the monitoring period

Water Discharge

- Water discharge and quality were compliant during the monitoring period
- Bank of four evaporators in Pit 3 approx. 150L/second throughput (12.9ML/d) with a current estimate on evaporation at 40% or ~5ML/d.

*Question: Are these evaporators in place because the water can't be treated through the RO Plant?*

*Answer: The evaporators are being used in Pit 3 to improve operation and allow mining in Pit 3 sooner. There is no issue with the quality of the water.*

*Question: Do these evaporators reduce the need for an additional RO plant?*

*Answer: WCPL are still looking at engaging a temporary RO plant in the future.*

Operational Downtime

- 1047.4 hours from 29 November 2024 – 26 February 2025; majority time lost due to lightning, rain, fog, dust and noise in that order

### Rehabilitation

- 86.1ha rehabilitation achieved in 2024
- Target for 2025 is 98ha
- Agricultural drone is due to arrive mid-March to support rehabilitation team function

### Complaints

- 29 November 2024 – 3 March 2025 total complaints 19 from four complainants

*Discussion regarding slide about an odour complaint that was independently invalidated by an Independent Attended Noise Monitoring person*

*Discussion regarding historic community odour complaints, context for the complaints and understanding the details of measuring, reporting and compliance with relevant odour conditions. Community observations that odour can move on air currents below prevailing wind direction.*

### Community Donations

- Six priority areas to support
- CCC members encouraged to share details of the sponsorship with the wider community, and to contact KB/CP directly or via standard channels to discuss potential sponsorship
- Mudgee Running Festival, Max Potential, Mudgee Veterans Golf Association, Cassilis Campdraft and Black Stump Rodeo (Coolah) have been supported thus far in 2025
- Doctors 4 Mudgee Region program is being supported as it gets up and running, with intent to participate in the program ongoing and provide monetary support

### Wilpinjong Camp

- Approximately 60 workers being accommodated at the camp currently
- Operation commenced in January 2025
- Workers are varied – some are new starters that are transitioning to living in the Mudgee region. There are some contractors in hard-to-fill roles
- The camp supplements available accommodation; it is not intended to ever accommodate all workers

## 9. REPORT BY CLARK POTTER

### EL9399

**Question:** *In the EPBC referral maps, there's a little loop in the map that extends out on the other side of the railway line. There's no explanation about it*

**Answer:** *There is some road and power line realignment which may explain. WCPL to provide explanation as to why the map in the EPBC referral is different to the maps provided during the CCC*

- Overview of the pathway forward talked to regarding the Pit 8 Modification, Pits 9 and 10 SSD and the future opportunities
- Timeline introduced showing the key milestones for the Pit 8 Extension Modification
- A similar timeline will be shown in the next CCC for the SSD

### Property Management

- 2024 demolition program of five houses in Wollar Village is complete
- Fuel tank at the former general store will be inspected by SLR in April 2025 which will determine next steps
- Mowing of village areas continues as usual
- Awaiting the waste contractor (bins) to remove remaining topsoil
- Weed and feral animal control – weed spraying complete for this season
- LLS starting a wild dog baiting program that WCPL is contributing to

## 10. GENERAL BUSINESS

**Question:** *Community questions the hot houses at the old nursery that are falling apart; could they be purchased by community members?*

**Answer:** *The nursery/hot houses are being used by the Native Title group; they are receiving quotes for fixing the hot houses. Seedlings are being grown there currently, with an irrigation system installed*

**Question:** *What is the current status of the Groundwater Management Plan? The 2023 is not published on the website*

**Answer:** *The GMP is under review (parked as a draft), awaiting for Departmental approval*

**Question:** *When is the Annual Review expected?*

**Answer:** *Submission by 31 March 2025; once through consultation with the agencies, WCPL will receive the formal approval of the document and it will be uploaded to the Wilpinjong website*

**Question:** *Could WCPL please comment on the salinity and groundwater drawdown that was noted as above predicted in the 2023 Groundwater Review as part of the Annual Review.*

**Answer:** *Groundwater is reported on monthly. An overview of the network of groundwater monitoring bores is discussed (including age and original intent of the water bores, as well as the climatic fluctuations over time).*

**Question:** *With Modification 3, the application is for the ability to produce up to 16MTPA up to 2033? What are the current conditions of extraction rates prior to 2033?*

**Answer:** *It's unlikely that these annual amounts will be reached,. Current approval conditions allow for WCPL to extract up to the limit, annually.*

**Question:** *How much does operational downtime impact extraction rate?*

**Answer:** *Environmental conditions heavily impact on the total extraction rate; especially wet weather.*
